

Zero In Ant Killer Powder is an insecticidal powder for the control of ants, woodlice, cockroaches, earwigs and other crawling insects. For use in the home and garden.

DIRECTIONS FOR USE

Shake the container before use. Unscrew outer cap. Snip the end off the crack and crevice spout. Point at the area to be treated and apply a fine dust of powder. Shake the pack during use if required with the cap on. Apply the powder to where the ants are running and into the ant's nest. Ensure the corners, cracks and crevices are treated where the ants hide. If ants are entering the home, apply powder to the ant's route and entry points. Avoid applying to damp or wet surfaces in the home. Repeat treatment as required. Replace cap after use and store product in a cool dry place. Always wash hands after use.

Note: Air space is left at the top of this container to enable puffer to function.
