**APPLICATION RATE**  
Surface Spray:  
Apply 50ml of product per 6.25 square metres of surface, or spray short bursts directly at insects.  
Space treatment (fog/ulv):  
Apply 0.4ml of product per cubic metre of treatable volume.

Important: Space spray containing pyrethrins or pyrethroids must not be used more than once a week against houseflies in intensive or controlled environment animal houses as they could cause control failure due to resistance. IF MORE FREQUENT TREATMENTS ARE REQUIRED, use a product with a different active ingredient and, if necessary, a different control method (such as bait).
