In respect of your application for Registration as a Pest Management User - Trainee pursuant to Reg. 18(1) of Statutory Instrument 427/2013, we are pleased to inform you that your application has been approved.

You have been included on the Pest Management User - Trainee register with effect from 12-Oct-2022.

Pest Management User - Trainee need to spend a minimum of 2 weeks field training directly with an experienced PMU. After 2 weeks field training, the trainee can work with indirect supervision for applications for which their supervisor has deemed them competent to carry out with limited supervision whilst awaiting formal training.

The trainee can ONLY carry out repeat visits with indirect supervision once their supervisor has signed them as competent to do so. The Trainee CANNOT conduct site assessments until registered as a full PMU.

Training records must be kept to prove the trainee observed and demonstrated on four separate occasions the safe application of biocidal products under direct supervision before they start working under indirect supervision. There should be one record per application/technique. Records can be requested for audit by the Pesticide Control Division (PCD).

A grace period of 9-months from the above date, allows the TRAINEE to gain necessary experience/mentoring and complete formal training. A certificate of completion from a Level 3 Ofqual qualification in pest management must be submitted within 9 months, extensions can be made where a course is not available within the 9 month period. Failure to submit the documentation will result in revocation of the TRAINEE PMU Number and the trainee can no longer legally use rodenticide for professional or trained professional use.

Your Pest Management User - Trainee number is PMU001943T. This number can be used as proof of registration.
